# MARION AND JOHN E. ANDERSON PAVILION: 10 YEARS OF EXCELLENCE

*A decade ago, the state-of-the-art building helped launch a new era of advanced care at Children's Hospital Los Angeles.*

The Anderson Pavilion increased the number of critical care beds at Children's Hospital by 40%.

**In 2011, Children’s Hospital Los Angeles opened the Marion and John E. Anderson Pavilion, creating an unparalleled medical facility in Southern California dedicated to caring for children.**

Marion and John E. Anderson, longtime supporters of CHLA, made a \$50 million gift to complete the state-of-the-art building designed to provide the latest treatments in a welcoming, family-centered environment.

Thanks in part to the family’s transformational investment—and the nearly 750,000 other donations of all sizes—Children’s Hospital Los Angeles is among the leading pediatric medical institutions in the nation, recognized for its excellent clinical care and supportive services. It is ranked fifth in the country and No. 1 in California by U.S. News & World Report.



Designed specifically with kids and families in mind, the Anderson Pavilion incorporates family-friendly amenities and advanced clinical spaces that create a healing environment for

patients and their loved ones. Many of these areas were made possible by generous philanthropy, including the Maurice Marciano Family Foundation Emergency Department and Trauma Center, the Ahmanson Foundation Pediatric Intensive Care Unit, the Thomas and Dorothy Leavey Foundation Cardiothoracic Intensive Care Unit, the Walt Disney Company Foundation Reception Area, and others named in honor of philanthropists who supported the hospital during the Living Proof Campaign.

“A core belief at our institution is that we achieve our best together, and the Anderson Pavilion embodies that,” says Paul S. Viviano, President and CEO of Children’s Hospital Los Angeles. “As we celebrate this milestone, I would like to thank all the donors who helped make this groundbreaking facility possible—many of whom still support the hospital to this day.”

Led by the Andersons’ daughter, Judy Munzig, the Anderson Stewart Family Foundation is among those that have continued their legacy of generosity at CHLA.

“The Anderson family is honored to continue our support of Children’s Hospital Los Angeles,” says Munzig. “The hospital’s steadfast devotion to its mission to provide world-class care to critically ill children inspires us and makes us very proud to be among its supporters.”

Now, more than ever, there is a significant need for the expert pediatric care, community support and early interventions that CHLA provides. “As I look back on the last decade with pride, I am struck by the bright outlook I see for our institution,” says Viviano. “And I’m grateful for the community of supporters who invest in children’s futures.” 🦋

**Kathleen McCarthy Kostlan has advocated for Children’s Hospital Los Angeles for decades.** As an individual philanthropist and head of the Thomas and Dorothy Leavey Foundation, she has donated more than \$10 million to the hospital—including a significant gift to the Living Proof Campaign, which helped support the construction of the Marion and John E. Anderson Pavilion. At the hospital, the Thomas and Dorothy Leavey Foundation name graces both the Cardiothoracic Intensive Care Unit and the Interfaith Center, demonstrating the foundation’s generosity that can be felt throughout the institution.

Kostlan, who first began supporting CHLA as a member of Las Madrinas and is a member of the hospital’s Foundation Board of Trustees, reflects on how Children’s Hospital Los Angeles has changed over the years, the impact of the Anderson Pavilion and why she continues to support the hospital today.

*The hospital has gotten nothing but better over the years. A decade ago, many people took it for granted, but what CHLA has become over the last decade is extraordinary. With leading doctors who have been recruited from around the world and the research being done, the hospital has earned all sorts of recognition. As its reputation has grown, people have come to know that Children’s Hospital is really something very special and very unique.*

*When the Anderson Pavilion was built, that made a tremendous difference—it really did. Buildings don’t make an institution, but it gave the hospital room to grow. Before the Anderson Pavilion was constructed, the hospital was using every inch of space—and I’m sure it is doing that now, too. Of course, the more space you have, the more children can be treated and the more space you need.*

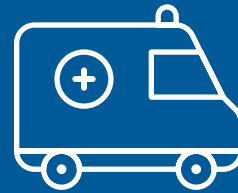

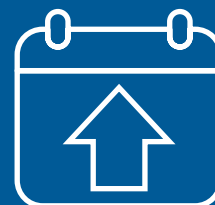

**The Thursday lunch rush is just getting started at Panda Express, and a line of people is slowly snaking around the glass display case of food. But above the lunchtime chatter and the hissing and steaming of giant black woks, you can hear something else: the quick, cheery double-ping of a call bell.**

((ding)) ((ding))

The half-dome, stainless steel bell sits by the register and is a tradition at Panda Express—celebrating each time a guest decides to donate to Panda Cares®, the company's philanthropic arm. On this day, the bell is ringing every couple of minutes, with nearly every guest choosing to chip in rounded-up change, \$1 or even \$2.

Together, these seemingly small donations have been adding up to a big impact for the community—and for Children's Hospital Los Angeles.

"We call it the Bell of Hope because in the hospital, when a child finishes a lifesaving

treatment, they get to ring a bell," explains Tina Hsing, Director of Panda Cares. "So when our associate asks for that donation, and our guest is inspired to say yes, we ring the bell. It symbolizes that a child gets to go home, that we're impacting a child's life."

Since 2003, Panda Express has raised more than \$19 million for Children's Hospital Los Angeles through Panda Cares. But the company's latest endeavor is even bigger: In 2020, the foundation pledged another \$20 million to establish the Panda Cares Center of Hope™ at CHLA. The Center supports a wide variety of programs and services that provide compassionate and healing care for patients and families.

"Panda Express is one of our largest corporate partners and one of our most devoted," says Lara Khouri, MBA, MPH, Executive Vice President and Chief Strategy and Transformation Officer at Children's Hospital Los Angeles. "I am deeply grateful not only for their ongoing commitment and vision, but also for their passion. Their whole team is truly dedicated to helping us create hope and build healthier futures for children."

## A shared vision

The spirit of giving has long been ingrained in the Panda Express culture. Led by co-Founders and co-CEOs Andrew and Peggy Cherng, the company established Panda Cares in 1999, with 100% of donations benefiting the community. The driving organizational principle behind it? "Good fortune is best when shared."



The foundation's main focus is to support the health and education needs of underserved youth. That mission—and the company's Los Angeles roots (the first Panda Express opened in Glendale in 1983)—made Children's Hospital Los Angeles a natural partner. Although Panda Cares now supports more than 130 pediatric hospitals across North America through Children's Miracle Network Hospitals, CHLA was the first.

"Children's Hospital Los Angeles shares the same vision as Panda, the same mission of helping to better the lives of children," Hsing says. "When we see the hospital's world-class care, and the impact it has on families year after year, we want to keep supporting it."

Over the past two decades, that support from Panda Cares has ranged from a \$100,000 gift in 2003 to a \$10 million gift in 2017 to name the sixth floor of the Marion and John E. Anderson Pavilion—and even a special panda sculpture that resides in the Emergency Department. Other donations include books and coloring sheets for hospitalized children (featuring a panda dot-to-dot and a fortune cookie game), as well as food and personal protective equipment during the pandemic.

Panda's latest pledge for the Center of Hope—part of a nationwide initiative with Children's Miracle Network Hospitals—

focuses on four key pillars of pediatric health: physical, emotional, mental and spiritual. The funding supports services such as social-emotional programs like music and art therapy, pet therapy, Child Life, the Literally Healing reading program, Spiritual Care Services and more.

"These services are critical to helping us tend to the well-being of children and their families, in addition to their medical treatment," says Alexandra Carter, CHLA Senior Vice President and Chief Development Officer. "This significant commitment from Panda Cares will help ensure that our hospital can continue to

provide the compassionate, family-centered care that is so vital to children's healing."

Carol Hamamoto, Manager of the Child Life Program at CHLA, sees the impact of these services every day. "It's so important to promote positive coping and help children and families process what they're experiencing in the hospital," she says. "To have a large company like Panda Express recognize the value of emotional well-being is really impressive and very exciting."

### Helping Make March Matter

Although Panda Express collects in-store donations for Panda Cares daily, its

efforts to support CHLA particularly shine during Make March Matter—the hospital's month-long fundraising drive with local businesses. The company has been the top fundraiser since the annual campaign began in 2016.

Nancy Lee, MSN, RN, NEA-BC, Senior Vice President, Chief Nursing Officer and Chief Clinical Officer for Children's Hospital Los Angeles, dines at her local Panda Express every March—and is amazed at what she sees.

"The Panda Express associates are incredible ambassadors for CHLA, asking all the guests who visit the restaurant if they'd like to donate and support the hospital," Lee says. "It's like they're a part of our fundraising team—and in many ways, they are."

Many associates chip in themselves, donating part of their paychecks once a year to Panda Cares. They also give their time—volunteering at food donation events, Boys and Girls Clubs and at the

Panda Cares Charity Golf Invitational, a fundraising event with business partners that benefits Children’s Hospital Los Angeles and other organizations. And this past August, the team celebrated Panda Cares Day at CHLA—delivering chocolate-covered fortune cookies to patients, families and staff.

“Our associates are so passionate about supporting Children’s Hospital Los Angeles,” Hsing says. “If I ask for volunteers, everybody says yes. If I ask for a donation, they say yes. It goes back to our company culture. It’s not just about making our signature dishes. It’s about bettering others’ lives.”

Lee is so impressed with their dedication that, during the annual Make March Matter campaign, she often passes out an array of CHLA-branded items such as hats and stickers to associates at her local Panda Express.

“It’s pretty cool to see all these people helping to raise funds for Children’s Hospital Los Angeles,” she says. “I just want to recognize all of them, and say thank you.” 🦋

## KENZIE’S FAMILY PAYS IT FORWARD

**Four years ago, Terrance and his wife, Jamie, were on a family vacation in Hawaii when they began to worry about their 6-year-old daughter, Kenzie.**

“She was losing a lot of weight,” remembers Terrance, Purchasing Operations Manager for Panda Restaurant Group. “And she was incredibly thirsty all the time.”

Jamie, who has Type 1 diabetes, recognized the signs, and shortly after they arrived home, Kenzie was diagnosed with the disease—a lifelong condition where the pancreas produces little or no insulin. Devastated, Jamie and Terrance began looking for the best possible care and support. Their research pointed them to one place: Children’s Hospital Los Angeles.

It was a place Terrance had been supporting for years through the Panda Cares® foundation. He’s volunteered at the Panda Cares Charity Golf Invitational since joining the company 19 years ago, and he participates every year in the Associate Giving Campaign. CHLA benefits from both fundraisers.

After Kenzie’s diagnosis, he and Jamie met Jennifer Raymond, MD, MCR, Chief of the Division of Endocrinology, Diabetes and Metabolism—and experienced firsthand the kind of leading-edge and family-centered care that CHLA provides.

“I had no clue how to manage carbs, give insulin—none of it,” Terrance says. “Dr. Raymond and her team have been so good at teaching me and providing care and valuable instruction to both of us. They’ve gotten Kenzie on a routine that is pretty much saving her life.”



Jamie adds that she particularly appreciates the nurse educators and the dedicated dietitian—as well as some of the extra, child-friendly touches CHLA provides.

“After every appointment, Dr. Raymond offers Kenzie a little toy from a cabinet,” Jamie says. “It’s such a small thing, but it makes a huge difference for a child who has to go to the doctor on a regular basis. She knows there’s a silver lining at the end.”

The biggest silver lining? Kenzie is doing great. Now 10, the fifth grader loves riding horses, tap dancing, swimming and drawing. Last year, she received a “Most Inspirational Student” award from the City of Long Beach. Several teachers and parents nominated her, impressed with her ability to manage her diabetes and school life so successfully.

For Terrance, his personal experience at CHLA gives him one more reason to support Panda Cares.

“I’ve always felt very fortunate to work for Panda, where it’s all about giving back and paying it forward,” Terrance says. “To be able to support Children’s Hospital Los Angeles through Panda, that’s like icing on a cake. It’s just a great feeling.” 🦋

# IN HONOR OF BELLA: A GRANDMOTHER'S SUPPORT FOR CHILDREN'S HOSPITAL

**You're the second level of support when you're the grandparent. So after her 19-month-old granddaughter, Bella, was diagnosed with advanced neuroblastoma, Marilyn Smith knew it was her daughter, Jennifer Smith, who would occupy the front line, spending day and night with Bella at Children's Hospital Los Angeles.**

What could she and her husband, Jack, do? What help could they provide? "That's when we started donating," Marilyn says.

Marilyn and Jack began giving to multiple areas of the hospital, supporting research into new treatments for the disease, a pediatric cancer that often originates in the adrenal glands, as it did with Bella. "It just felt right, donating," Marilyn says, "not just to help Bella, but to improve the survival rates for all children."

The high-risk neuroblastoma that Bella faced—meaning it had spread throughout her body—has a discouraging prognosis. The five-year survival rate is 40% to 50%.

"I used to pray when she was 3 and 4," Marilyn says. "When she was doing a lot of heavy-duty treatment—chemotherapy and stem cell transplantation and immunotherapy and all that—I used to think, 'If she could just get to kindergarten.' That was my hope—that she just get to kindergarten."

### **'Mom, are you donating?'**

Bella made it to kindergarten and kept going. Now age 12, she has been in remission for 8½ years. Though she's experienced some side effects of chemo, including hearing loss and diminished bone growth, she's a high-achieving middle schooler who sews and bakes and has a beautiful singing voice, according to her mother.

"If you look at her, she's a healthy, sassy teenager," Jennifer says. "No one would ever know what she's endured."

A resident of La Verne, about 35 miles east of Los Angeles, with a job as a health care administrator, Jennifer knew about Children's Hospital Los Angeles. She had friends whose children had been treated there. "I had heard of it and how great it was, but I never had any experience there," she says. "Now I will sing about it from the rooftops."

She was unaware that her mother was donating to the hospital until she received a card in the mail informing her that a contribution had been made in Bella's honor. Printed on the card was the name of the gift's source. "I was like, 'Mom, are you donating?'" Jennifer says. "And she said, 'Oh yeah, I have been since Bella got sick.' I had no idea.

"The oncology team talks about the resources needed to do research, to try to get to the next discovery," she goes on. "They say about every 10 years they find something that adds to the treatment. Having my mom contribute to that is awesome."

### **Giving where it's needed most**

Marilyn, 74, grew up in Los Angeles but since 1970 has lived in Ojai. She and Jack, who passed away in 2018—both lifelong educators—gave frequently to local charities supporting health care and education.

"We could see the fruits of those donations," she says. "Those are the kinds of things that we always felt we wanted our giving to go toward—things that we could see."

That drew them to Children's Hospital Los Angeles. They could see the impact of their giving, the groundbreaking work it enabled, and the lives it saved or improved. Their initial contributions supported Anat Erdreich-Epstein, MD, PhD, who at the time was Bella's oncologist and was collecting donations as a participant of the Malibu Triathlon, an annual fundraiser that benefits cancer research at the hospital.

Marilyn and Jack also gave to a research consortium called New Approaches to Neuroblastoma Therapy (NANT), which is headquartered at Children's Hospital Los Angeles. NANT's Medical Director of Operations is Araz Marachelian, MD, MS, Director of CHLA's Neuroblastoma Program, who took over Bella's case. NANT includes numerous organizations dedicated to using clinical trials to develop new therapies for neuroblastoma.

Marilyn says the hospital is now the focus of her gift giving. She trusts each donation will be put to good use, so she leaves it to the hospital to decide where it should go.

"Usually I write some kind of note that says, 'Please use where it's most needed,'" Marilyn says. "I want my donation to be like boots on the ground. Use it where it can be most effective. I just like to know that it's being used to help research, to help the most vulnerable, to improve survival rates."

Donating also gives Marilyn an avenue for expressing her gratitude, thankful that her daughter and granddaughter live within driving distance of an elite pediatric care center like Children's Hospital Los Angeles.

"As Bella got better," she says, "I looked at it as an opportunity—an opportunity to share about Children's Hospital, and an opportunity to help families keep their children alive." 🦋

**As sisters and best friends, Marilyn Wallace and Sami Freedman are so close they finish each other's sentences—and they definitely agree on the legacy they want to leave.**

Talking about their generous planned gift to advance cancer research at Children's Hospital Los Angeles, Marilyn begins cheerfully, "This will be a special legacy for us at Children's Hospital, especially because neither of us has children of our own. It's our way—" then Sami adds "of helping so many children."

The sisters—both cancer survivors—know firsthand about the importance of nurturing new research.

"We share a passion for curing cancer," says Marilyn.

"It's the right thing to do," Sami adds with enthusiasm.

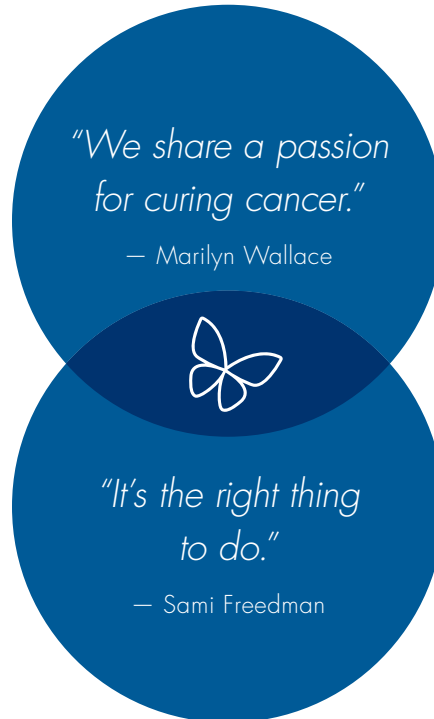
### **An example of generosity**

The Rosinsky sisters were born in Omaha, Nebraska, and came to California when their parents moved west and settled in San Francisco. At ages 10 and 7 respectively, Marilyn and Sami thrived. Their father, Art, was a successful business owner who frequently dug deep into his own pockets to help friends and strangers in need. Their mother, Ruth, volunteered at a local hospital.

The siblings were influenced by their parents' spirit of generosity and philanthropy. As the sisters forged their way in the world, their own giving priorities took shape.

Never too far apart, they next moved to Los Angeles—first Marilyn to attend college and become a second-grade teacher, then Sami, who started a successful business. One day, a client suggested she consider contributing to cancer research, and Sami took the idea to her sister.

After marrying, Marilyn and Sami and their husbands, George Wallace



and Bob Freedman, respectively, joined Couples Against Leukemia, which for decades has held a unique annual fundraiser, taking about 200 people on a day of adventures around L.A., including such stops as a sumo wrestling demonstration, trapeze lessons and a tour of Dodger Stadium. All proceeds from the events, which the sisters often help organize, support leukemia research at Children's Hospital.

### **Belief in their cause**

Marilyn and Sami's relationship with Children's Hospital has only deepened over the years. "We feel we are a part of Children's Hospital," says Marilyn. "It's in our blood."

Adds Sami, "We've bonded."

They have toured the hospital numerous times, spoken with CHLA doctors and nurses, and been inspired by its young patients. By a coincidence, Marilyn's husband, George, was a patient at Children's Hospital Los Angeles when he was involved in a household accident at age 7.

A few years ago, Marilyn and Sami extended their meaningful relationship with the hospital by naming a patient care room in the Cancer and Blood Disease Institute in honor of their husbands, who have both passed away. Recently, they established a larger estate gift to support innovative investigations in cancer research and to pay tribute to their beloved family members as well as their own commitment to helping children with cancer.

"We want to honor our treasured parents, Art and Ruth Rosinsky, and our precious grandmother, Sara Silver, along with our beloved late husbands," the sisters said in a joint statement. "What better way to do this than to include Children's Hospital in our estate plan, hoping our loved ones will be remembered, and our gift will fund new discoveries and help Children's Hospital find a cure for cancer."

### **'Doing something great'**

To others who may be wary of making their estate plans, Marilyn says, "Don't be afraid to think about it." Sami adds once more, "You'll be doing something great."

Now widowed, the sisters have shared a home since 2005. They enjoy playing cards, boating, reading and exercising, and have a love for travel and theater. But the young patients at Children's Hospital are never far from their minds.

At times, they invite friends to see the hospital they love. "Some people think it will be depressing," says Sami. "It's just the opposite; it's so uplifting and the children are amazing."

"You feel very good knowing there is a place like this that any child can go to, no matter how much or how little money their family may have, and get the life-saving help they need," adds Marilyn.

"It is such," they say, echoing one another, "a wonderful place." 🦋

# A COMMON CALLING

*Antonia Hernández, President and CEO of the California Community Foundation, calls CHLA ‘one of the jewels of Southern California.’*

Separated by just 4 miles, Children’s Hospital Los Angeles and the California Community Foundation (CCF) share more than just geographic proximity. “In many ways, we have a common calling,” says Antonia Hernández, CCF’s President and Chief Executive Officer. “We’re both striving to serve the poorest, the most vulnerable, the sickest, and to protect the future of our community.” CCF’s partnership with Children’s Hospital—one that spans nearly four decades and totals more than \$20 million in grants—has allowed the two organizations to address some of the most pressing health needs of children in Los Angeles and beyond.

## **1 CCF provides grants through donor-advised funds and its own Centinela Medical Fund. Why has the foundation chosen to continuously support Children’s Hospital?**

There are, what we like to call, the 10 organizations—institutions that are staples of our grantmaking, and Children’s Hospital Los Angeles is one of them. When donors come to us, we like to talk to them about their passions and what they want to achieve with their gift. If they use the words “children” and “help,” we’ll tell them, “Children’s Hospital.” It is one of the jewels of Southern California. The level of patient care it provides is not just healing a broken foot or taking care of a single issue. There’s an attention to the mental well-being of children and truly understanding them. That’s what CCF wants to promote and support.



## 2 The most recent CCF grants to CHLA were for substance abuse and diabetes prevention. Why was it important to direct funding to these two areas?

Children's Hospital patients come from all sectors and walks of life, but many come from poorer communities, some of which are considered food deserts because they lack markets with fresh food. In many instances, these children start their lives not being able to access proper nutrition, and the consequence as they get older is that they develop diabetes and obesity. Patients could also be from families that are suffering from substance abuse. These two topics hit at the heart of our focus with helping the working class, because how a child grows up—either with healthy options or at risk of developing an illness that poverty often leads to—can change his or her life.

## 3 How has the pandemic affected CCF?

I am so proud of how the Los Angeles donor community has come together over the past year. Our donors have risen to the task, and CCF has had its most successful fundraising year despite the pandemic. The money that came in was put to work immediately. That said, we have certainly faced challenges like everyone else. Our infrastructure has been stretched, and our staff have had to balance their own personal lives with being out in the community. We're in the people business just like Children's Hospital, so we can't take a break. We have to continue to be out there and serve. With COVID-19, I think many of us realized just how connected we all are. Our future and health are connected to the well-being of everyone else, so if our community is not healthy, we are not healthy ourselves.

## 4 During your 17-year tenure as CCF President and CEO, you have visited CHLA several times. Is there a moment that is particularly memorable for you?

Although I have a professional relationship with the hospital, it's the personal one that matters most. Children's Hospital Los Angeles is the best pediatric medical center in the area, a place where people go to really get the high level of care and attention a child needs. Years ago, I had a young family member who was seriously ill and received care there. I think back to when we thought we might lose her, and today, how well she is doing and how healthy she is. Because of that, Children's Hospital will always be a special place for me.

## 5 Looking ahead, how do you envision the collaboration between CCF and Children's Hospital Los Angeles will evolve?

Children's Hospital is in a unique situation because of its specific niche—serving some of the most vulnerable children—and therefore I foresee our relationship continuing. From a humanity standpoint, children are our future, and the health of our society is based on the health of children. So we need to continue to support that future even long after we're gone, and Children's Hospital plays an important role in that. Both of our organizations care deeply about the place we live in and its people, and we feel very privileged to be able to partner with the hospital. 🦋

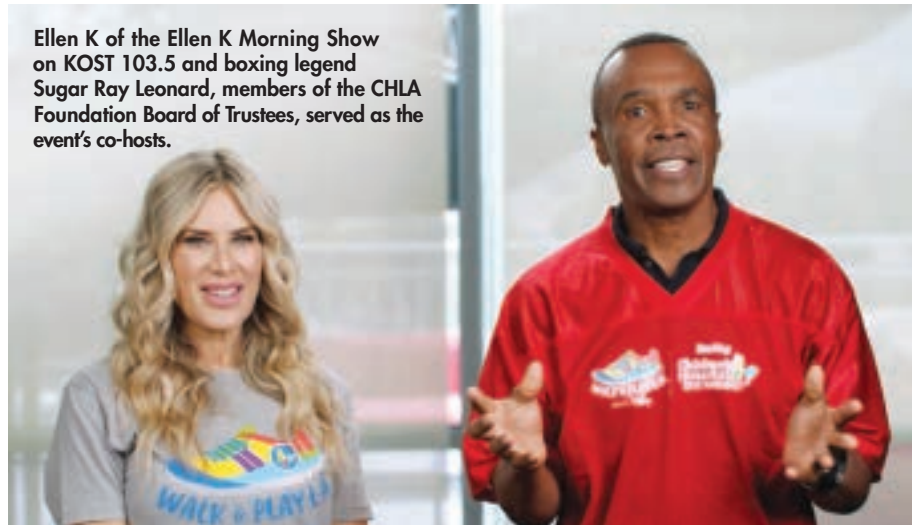
